# **Cookies Policy**

### 1. General Information

This Cookies Policy (hereinafter referred to as the "Policy") sets out the rules for the use of cookies and similar technologies within the website available at <a href="https://betclic-clash.com">https://betclic-clash.com</a> (hereinafter referred to as the "Website").

The controller of the Website and the entity responsible for the processing of personal data in connection with the use of cookies is **WTV sp. z o.o.**, with its registered office in Wrocław, Poland, entered into the National Court Register (KRS) under number **0000593878**, NIP: **5862302397**, REGON: **363302932**,(hereinafter referred to as the "Controller").

#### 2. What are Cookies?

Cookies are small text files that are stored on the user's device (computer, smartphone, etc.) when visiting the Website. Cookies serve to improve the user experience and functionality of the Website.

## 3. Purpose and Scope of Cookie Usage

Cookies are used for the following purposes:

- ensuring the proper functioning and display of the Website,
- adjusting the Website's content to the user's preferences,
- collecting statistical and analytical data about the use of the Website,
- improving performance and user experience,
- ensuring session security.

Cookies may also be used by third-party services integrated with the Website (e.g., analytics tools).

#### 4. Types of Cookies Used on the Website

The Website may use the following types of cookies:

- Essential (technical) cookies required for the correct operation of the Website, including navigation and access to secure areas. These cookies do not require user consent.
- Analytical cookies used to collect statistical data about how users interact with the Website. These cookies are only used if the user gives explicit consent.

The Controller may use third-party services, including but not limited to:

- Google Analytics (Google LLC),
- other similar services for measuring website traffic and optimizing content.

If services from providers located outside the European Economic Area (EEA) are used, data may be transferred outside the EEA in compliance with Article 46 of the GDPR.

#### 5. Cookie Consent and Management

Upon the first visit to the Website, the user is informed about the use of cookies and has the option to manage cookie preferences via the cookie banner. Consent may be withdrawn or modified at any time through:

- the Website's cookie banner settings, or
- the browser's cookie settings.

Restricting or disabling cookies may affect the functionality of some parts of the Website.

#### 6. Retention Period for Cookies

The duration of cookies storage depends on their type:

- **Session cookies** deleted after the browser session ends,
- Persistent cookies stored for a defined period or until manually deleted by the user.

Specific retention periods may be defined in the privacy policies of third-party providers, e.g. Google: https://policies.google.com/privacy

The Controller reserves the right to amend this Policy at any time, particularly in response to changes in legal regulations or the Website's functionality. Updated versions of the Policy will be published on the Website with the date of their entry into force.
